Minutes of the Annual General Meeting held on Wednesday 8th February 2023

Welcome

Mr Neale Sadler, Club Chairman, opened the meeting and welcomed everyone to the 91st AGM. There were 20 members present with 9 apologies received. He stated that he was delighted to see the Club's success last year and gave thanks to all the coaches and volunteers who created the success. He also gave thanks to Gary, Jan and all the bar staff for the fantastic job they do.

2. Members Remembrance.

A period of silence was held to remember Angela Walmsley, Derek Smout and Maggie Allens mother who had all sadly died during the year.

3. Presentation of the Simon Lines Shield

The Chairman presented the Simon Lines shield.

The 2022 winner is Lawrence Allen

Lawrence has been a huge asset to the Club for many years with his professional work as DJ and Emcee on many occasions as well as providing support for the football tournaments and jubilees etc. We are sorry that he is retiring from his role as function support but he has agreed to assist in handing the role over to Neil Bowen. The Club is very grateful for the fantastic job Lawrence has done over the years and for the continued use of his equipment after he retires. He will be missed

Lawrence thanked the Chairman and members and said he was immensely proud to receive the Simon Lines Shield and felt very honoured. He said it was particularly special as he knew Simon well and he was such a wonderful young man.

4. Minutes of the Last Annual General Meeting.

The minutes of the Annual General Meeting held on the 9th of February 2022 were confirmed as a correct record, and signed by the chair.

5. Chairman's Report

The Chairman said last year all the committee members were re-elected en-bloc. This year however, is a year of change as halfway through the Year our Chairman, Vinny Lines, had to stand down for health reasons and Neale, the Vice Chairman, took over. Neale thanked Vinny for the great job he had done during the 6 years of his tenure, Vinny will remain a Trustee. Brian Hughes is also standing down as Club Secretary and will be sorely missed as will Lawrence who is also standing down.

We do have people will to take on the roles which will hopefully enable a smooth succession.

Neale took over in the summer at the time of some junior football issues which are hopefully now resolved. He thanked the football committee who have now stood down, Pauline Best, Tim Wakefield and Alan Groom for all the work they have done for the junior football. We now have a new junior football Chairman, Liam Reynolds whom we will work closely with.

6. Treasurer's Report

Paul Prince presented a spreadsheet showing the Club's 2022 accounts

 The bar sales for 2022 were £210.7k which was up 11.6% on the 2019 figure of £181k which was our previous record. This gave a gross profit of £118.3k at 56.14% which is a brilliant effort. Particularly at a time when the entertainment trade is struggling. It is a magnificent effort by Gary, Jan and all the staff. Also, the support of members has been great which is reflected in the figures.

- Paul reported that the club membership had raised £5435 up 16.38% which has been helped by the new card system.
- Paul reported that the grants and donation of £21.9k included £4k council grant and a £7.5k grant from the Football Foundation
- The total income came to £177,779
- On the expenditure the major outgoings as usual were wages (£96.4k) up 10%, maintenance (£33.7k), heat light and power, (£8.1k), entertainment (£14.7k), insurance (£3.1k) and depreciation (£6.1k). The total expenditure was £173,383 which gave a surplus of income over expenditure of £4.39k which is very healthy considering the past 2 years.
- Paul thanked Gary and Jan for doing such a great job, Duncan for his work outside, and Phil for his maintenance repair work as well as all the people who give their time to help make the Club such a success.

The Chairman thanked Paul for the very professional job he does as Treasurer and for his expertise in producing such a comprehensive report. Also, it is great to see the Club continuing to improve and that this is the best facility in the County so thanks to everybody for their contribution.

7. Sporting Section Reports

BOWLS

Barbara Ford provided the following report:

- Prees Bowling Club put out 6 teams of 10 each last season in the Whitchurch and the Market Drayton Leagues plus competitions. This was due to the magnificent efforts of the captains and many thanks to them. The Whitchurch League A team won the Consolation Jubilee Doubles Competition and the Market Drayton A team won their division. Nigel Davies won most wins in the Market Drayton League 4. Congratulations to all.
- It is hoped to encourage more people to join the bowling club and play bowls. We are wanting to put 2 new teams in the leagues.
- We have coaching courses arranged for 11th and 18th of March, weather permitting, at Prees. We have two great bowling greens lovingly nurtured by Duncan please come and have a go.
- Thanks to the Prees Cricket and Recreation Club for their continued support.
- Barbara has produced some flyers to publicise the Bowls for distribution in the village.

The Chair thanked Barbara for her report and for taking on the bowls secretary role and attending committee meetings.
